This Contract Form and Schedule confirms the terms of your recent agreement with SSE Energy Supply Ltd. This document forms part of the Principal Terms of Contract and/or Statement of Renewal terms applying to Micro Business Contracts and must be read in conjunction with those statements.

As standard, Your Prices include the provision of 100% renewable electricity generated by wind and/or hydro assets wholly or partially owned by SSE Group. If Your Prices also include SSE Next Generation (please refer to the Prices on Your Contract), You will be able to trace your 100% renewable energy supply to named wind and/or hydro assets wholly or partially owned by SSE Group. Please refer to Our standard terms and conditions for additional terms that apply for SSE Next Generation.

This contract is on the condition that you already have an AMR or smart meter installed at the Supply Point. Where this is not the case, SSE will offer you a range of dates to have your metering upgraded as part of our smart meter rollout. If an appointment is not accepted and a compliant meter not installed, through no fault of Our own, within 90 days of us first contacting you to arrange an appointment for installation, then you will revert to our Variable Business Rates. If, once you have reverted on to Variable Business Rates, an AMR or smart meter is installed then you can renegotiate to go back onto a fixed term contract after 30 days from the date of the meter installation.

Payments are to be made by direct debit: which can be either variable, where the full amount is deducted from your nominated bank account within 14 days of the invoice date, or fixed/budget, where a fixed amount (determined by us) is deducted from your bank account on a monthly basis, unless an alternative payment method has been agreed. If your contract is based on direct debit payment and you later cancel or recall the direct debit, your unit rate will increase by 0.5p/kWh.

This contract is not complete until accepted by SSE and we reserve the right to withdraw the prices at any time without notice before our acceptance. Acceptance by SSE is the purchase of Energy by SSE for the supply that this contract applies to. SSE terms and conditions include provisions which limit SSE's liability to the customer. NB: The Supply start date may not be the date proposed on this form, the actual start date will be subject to us having a confirmed registration as supplier for each supply point.
